NO-COST TMS CONSULTATION

Your patient will receive a virtual or in-person consultation with a TMS expert at no cost. This is an opportunity to learn more about how TMS may work for them.

INSURANCE & COST ASSESSMENT

A TMS Care Coordinator checks insurance benefits and assesses any out-of-pocket costs. We also request prior insurance authorization, appeal denials of coverage, and offer payment plans.

SCHEDULE FIRST VISIT

After insurance authorization (typically takes 5-10 business days for commercial insurance), we will schedule the patient their initial one-hour TMS appointment within a week.

TMS TREATMENT SERIES

TMS treatment course consists of 30-36 sessions, typically scheduled five days a week for around 30 minutes. We are flexible with scheduling and offer TMS at all our locations for convenience.
